- To train the women on savings and group dynamics
- To equip them on record management
- To train the women on life skills
- ❖ To train the women with leadership skills
- To train the groups on vision journey/map

i) Emerging issues (including questions raised) identified during implementation of the activity

The project focal person Koboko Municipal Council in his opening remarks thanked CERID for the wonderful job done since the time of group formation up to date and encouraged CERID to work with existing groups because such groups have bond that brings them together than newly formed groups for a particular project. He also encouraged the group member to be united and utilize this opportunity correctly to develop their groups and their families at large. He informed the participants that COVID 19 is still there and Ebola is in the county and every one need to be aware and practice the SOPs to stay safe and healthy.

- The Chairperson Ilimika women group raised a question to inquire whether support will cover their rent when given the startup kits since they are dealing produce buying and selling that needs space. And this was answered by the project officer that the support does not cover rent it will be the responsibility of the group to provide the rent space for their items.
- The treasurer Dongoji-natelemera women group raised a concern that as women for them to develop the men must be brought to board and attend such trainings because they are the ones discouraging women in development and also requested CERID to bring women in to groups and support them as many are left behind.
- The LC111Chairperson West Division in his closing remarks thanked CERID and requested the groups to take advantage of this support that has come because it does not come every year or month and some of the government programs phasing out in the system . He also encouraged information sharing among the group members on markets and prices .he also requested CERID to develop an M&E tool to monitor and measure the progress of the groups that are supported and this will help them as stakeholders to follow up this groups.

 - ➤ Poor time management by the participants which delayed the morning sessions to begin. The participants were encouraged to be time managers in every activity they are under taking in their life.
 - The number of participants exceeded the planed budget this was as a result of baby setters were more than planed which has affected the budget.
 - ➤ High expectation by the participants in terms of facilitation.
 - ➤ Late disbursement of fund leading to late activity implementation.
